As a result, this Winter School will focus on 'The Interplay of Law and Politics in Shaping Future European Union' and will be ideal for members of the civil society in Cyprus and beyond, policy-makers, stakeholders, professionals and frontliners, PhD students, early career researchers, and advanced students in the fields of law, European studies, sociology, or politics.

The Winter School will employ a melange of formal and non-formal educational methodologies, placing the learner at the epicentre of the learning process. It will include a series of interactive workshops and lectures led by experts, providing learners with the opportunity to actively engage in discussion.
